### 1. Facilities and Improvements

- 5. We have or are preparing a comprehensive parking management plan.
- 6. We have shared parking arrangements with neighboring businesses.

### 3. Promotions, Services, Policies

Your organization is required to provide at least five (5) benefits. Check all that apply.

- 1. We provide free or reduced price (at least \$30 per month per pass) transit passes for at least a six-month period (residential use only).
- 2. We provide an outlet on site to purchase public transportation fare media.
- 3. We provide commuter information on our website with links to regional and real-time travel information.
- 4. We distribute or allow others to distribute travel behavior surveys or transit and ridesharing information via newsletters, emails or other means to commuters and residents on our site at least annually.
- 5. We provide monitors that display Real-time Traveler Information including public transportation, carpool, and vanpool messages.
- 6. We provide and promote commuter benefits at on-site Transportation Fairs or benefit fairs.
- 7. We actively promote changes in travel behavior on Ozone Action Days, weather emergencies, and other similar episodic emergencies.
- 8. We continually encourage employers onsite to promote flexible work strategies including compressed work weeks that reduce vehicle trips to and from the site.
- 9. We continually encourage employers onsite to promote telecommuting.
- 10. We are members of a Transportation Management Association (TMA) or other transportation organization.
